On non-school days, students are allowed a flat amount of hours depending on the extended care plan you pay.

# VPK STATEMENT OF FINANCIAL AGREEMENT

I, the undersigned, do understand that tuition payments are due the 1ST OF THE MONTH (August 1st-May 1st). **A LATE FEE OF \$60.00 PER CHILD WILL BE CHARGED IF TUITION IS NOT RECEIVED BY THE DUE DATE.**

I understand that the Registration and Supply Fee is a **non-refundable/non-transferable** fee.

I understand the Supply Fee will include part consumable books and school supplies and that this fee is **non-refundable** once school begins.

I understand there will be a charge for returned checks.

I understand that students will not be admitted to class if any fees are one month in arrears. Students who attend one day or more of an payment period will owe the full payment period tuition. No records or grades will be issued or transferred if there are any unpaid fees. I agree to pay any and all collection charges which might be incurred by First Baptist Brandon Christian Academy in collecting my outstanding balance.

If you have a child who will soon be 4 years old, you know how curious she is or how much he may already know. VPK is a free educational program that helps your child be ready for kindergarten. VPK helps build a strong foundation for school using educational materials appropriate for different stages in your child's development.

### What are the eligibility requirements for VPK?

Children must live in Florida and be 4 years old on or before Sept. 1 of the current year to be eligible. If their birthday falls from Feb. 2 through Sept. 1, you may wait to enroll your child the following year when they're 5.

### How do I apply for VPK?

You can apply online from a computer, mobile phone or other digital device by visiting [www.familyservices.floridaearlylearning.com](http://www.familyservices.floridaearlylearning.com). You will need an email address, proof of Florida residency and proof of your child's age to apply.

Your local early learning coalition will review your application and email you with further instructions. Once your application is approved, the coalition will provide you a Certificate of Eligibility you can take to any VPK provider.

# Florida's Voluntary Prekindergarten Education Program

## Fact Sheet for Families

### What kind of VPK programs are there?

Private, public and charter schools, private child care centers and specialized instructional services providers may offer VPK.

As a parent, you can choose one of the following:

**School-year program**—540 instructional hours. Class sizes of 20 or fewer students. At a minimum, instructors must hold a *Birth through Five Florida Child Care Professional Credential* and complete special training on early literacy and performance standards.

**Summer program**—300 hours of instruction. Class sizes of 12 or less. Instructors must hold a bachelor's degree.

**Specialized Instructional Services program**—hours vary based on services provided. For

children with disabilities who have current individual educational plans (IEP) developed by local school districts.

### How do I find a VPK provider for my child?
